Welcome and Opening Remarks

Dr. A. U. Patel, Chairman of Academic Council, welcomed the august body and introduced the members with great pride. Thereafter, the Director of Atmiya Group of Institutions, **Dr. J. N. Shah**, highlighted on the overview and requirement of autonomy. He said that the University system was unable to ensure uniform quality and it is becoming increasingly difficult for a University to attend to the varied needs of individual colleges. He also mentioned the credentials of Shree M. & N. Virani Science College and exhorted that the implementation of autonomy will enhance quality in all dimensions of college.

He also stressed that education in this autonomous college would not only include academics, but, in keeping with the principles of the Management and **Secretary, P. P. Tyagvallabh Swami**, also inculcate Universal Human Values through compulsory courses in the curriculum(his presentation is attached).

The Chairperson, **Dr. A.U. Patel**, then took up the agenda point by point

Agenda 1. Information on Autonomy of Shree M. & N. Virani Science College, Rajkot from A.Y. 2016-2017 and onwards by the Chairman of Academic Council

The Chairperson informed the members that the Shree M. & N. Virani Science College was established in the year 1968. The mission of Shree M. & N. Virani Science College is two fold: "**responsible**" and "**responsive**." The former involves the long view of the college's mission and



society's needs. The latter addresses the immediate strategies for meeting the short-long term academic and social requirements of the community.

He emphasized that

- UGC recognized the Institution as “College with Potential for Excellence” (CPE) in the year 2010-11. It was the first college under Saurashtra University and Saurashtra region of Gujarat State to this status of CPE by UGC
- Colleges with Potential for Excellence (CPE) need more autonomy and other academic credentials
- The college was accredited in NAAC Cycle-1 (2007) with ‘A’ Grade and re-accredited through NAAC Cycle-2 (2013) with ‘A’ grade with CGPA-3.28.
- Teachers need more academic freedom in teaching and evaluation.
- Stakeholders should be provided with more responsibility.
- Shree M. & N. Virani Science College was the first in the Saurashtra University and one among the first two in Gujarat State, to be conferred autonomous status

The UGC has granted Autonomous Status to the College with effect from 2012-2013 vide its letter No. F.22-1/2012AC, 16-01-2013. (Appendix I), which is being implemented from 2016-2017 and onwards.

The need, objectives and scope of functional autonomy were also highlighted as indicated in the Notes.

Dr. Sheela Ramchandran, explained about the history of autonomy in India from 1978 and with her long experience, commended that autonomy in its actual essence, is an instrument for promoting academic excellence for any college.

After further discussion the information of the above matter **was recorded**.

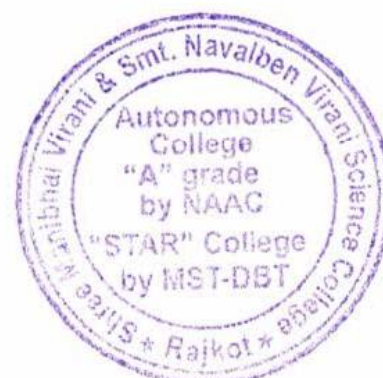

Virani Science College, a separate committee as **Research Advisory Committee** may also be included as Non-statutory Committee.

Dr. S.P. Singh also suggested inclusion of **Women's Cell** to take care of women's empowerment and Anti-sexual Harassment in campus, as mandated by the UGC.

Hence, the above 2 committees were also included.

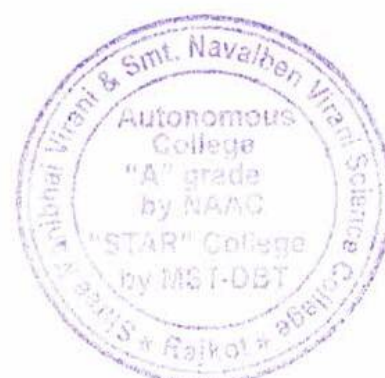

Dr. (Mrs) D. P. Chauhan enquired whether transfer of credits and transitory provisions would be made. The Chairperson informed that these provisions would be made in amended Regulations.

The members approved the introduction of the Choice Based Credit System (CBCS) in the course from A.Y. 2016-2017 & onwards, as per the UGC's Guidelines.

The Chairperson of the Academic Council moved the following resolutions

a. Awarding of Credits

The credits would be awarded as indicated below for various components.

- **Theory** --- 1 hour of instruction = 1 credit
- **Practical** --- 2 – 3 hours of instruction = 1 credit
- **Tutorial** --- 1 hour of instruction = 1 credit

b. Components of CBCS Framework

i. UG Programmes

The components were kept in line with the UGC's Guidelines and categorized as follows:

- Part I** English Language Courses
- Part II** Core, DSE and Generic Elective courses
- Part III** Ability Enhancement Courses

ii. PG Programmes

The components of the same were decided based on the academic, research, job and life skills expected from a Post graduate as indicated below:

Mr. Jignasu Chauhan moved the resolutions 6.6.1 to 6.6.9 as indicated in the Notes.

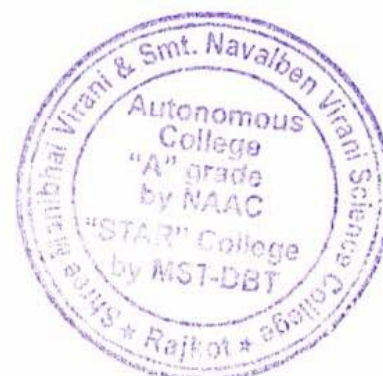
The above were approved and seconded by **Er. Ravi Tank**.

The typographical errors in the resolution 6.9.1.1, viz the word *Meditational Botany* and *Meditational Botany-Practical* were replaced by **Medicinal Botany** and **Medicinal Botany Practical**, respectively. The above were **approved** and **seconded** by **Mr. B. G. Paneliya**.

6.10 Resolutions of BoS in English

Mr. H. L. Pandya moved the resolutions 6.10.1 to 6.10.3 as indicated in the Notes.

He highlighted that majority of students are from rural background and poor in English language. So, in the first two semesters foundation courses in English will be taught and in 3rd and 4th semesters, more advanced course to empower the communication skills would be taught which will be highly beneficial for the students.

Dr. Sheela Ramachandran observed that Communication Skills was not only English language, but being able to express one's thoughts with clarity and common understanding. Therefore, clarity of thought, vocabulary, sentence formation and other skills for any form of communication were important. Of course, English being the universal foreign language being used, English language will be taught in the first four semesters, followed by intensive Communication Skill training in the 4th & 5th semesters.

The above were **approved** and **seconded** by **Er. Ravi Tank**.

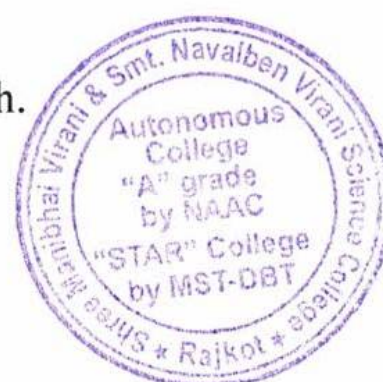
6.11 Resolutions of BoS in Interdisciplinary

Dr. Sonal Shah highlighted that education, which has a fundamental role to play in personal and social development, has been used to create a more skilled workforce, but often at the cost of the holistic development of the whole person. She also gave stress on exposure of value education to the students for betterment of society and progress of Nation which was unanimously accepted by all members.

Dr. Sheela Ramchandran highlighted on the mandatory need for Environmental Science by the UGC, and reiterated the need for value education.

She explained the concepts of the evaluation norms for both.



Dr. (Mrs) D. P. Chauhan enquired on the provision for completion of the two courses if a student fails to complete it. The Chairman indicated that the Guidelines for all 100% CIE will be made.

The typographical error was indicated and the table in **6.11.5 C** was deleted and replaced with following:

The above were **approved** and **seconded** by **Dr. Vishal Narodiya**.

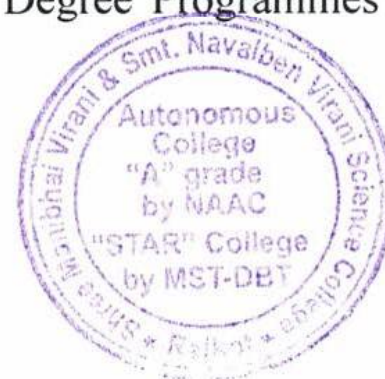

Dr. A. U. Patel, highlighted about the UGC's Gazette Notification on Specification of Degree dated **5th July, 2014** and **21st July, 2015**, wherein UGC has indicated that Universities/Institutions may introduce Integrated and Dual Degree Programmes judicially. A



dual degree programme combines more than one subject, mostly in a horizontal spread, whereas an integrated programme is **progressive** and **cumulative**. An **integrated approach** should involve a **vertical/inter-disciplinary** discourse.

The Chairperson also highlighted the conditions and general instruction by the UGC regarding Integrated Programmes. Based on the importance of commencement of Integrated Programmes and their impact on student readiness, industry fit and intensive academic pursuits, the Chairperson proposed the following:

10.1 Introduction of the following Integrated Programmes

- 10.1.1 Integrated M.Sc. Biotechnology Programme.
- 10.1.2 Integrated M.Sc. Microbiology Programme.
- 10.1.3 Integrated M.Sc. Chemistry Programme.
- 10.1.4 Integrated M.Sc. Information Technology and Computer Technology Programme.
- 10.1.5 Integrated M.Sc. Mathematics Programme.

10.2 The above Programmes be introduced from the **A.Y. 2016-2017 & onwards.**

The members **approved** the above and **authorized the Chairman of Academic Council** to take further necessary action pertaining to duration and other regulations; curriculum, syllabi and evaluation norms; and uniqueness of the programmes, keeping the future interests of the students in mind.

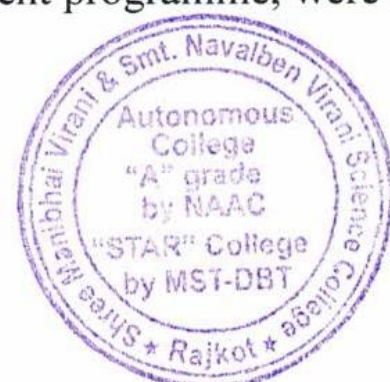
General comments by members
