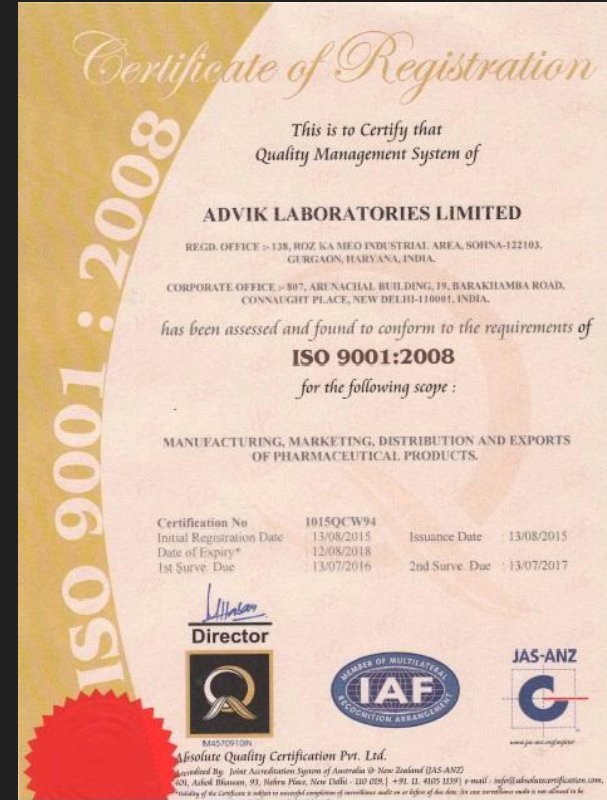

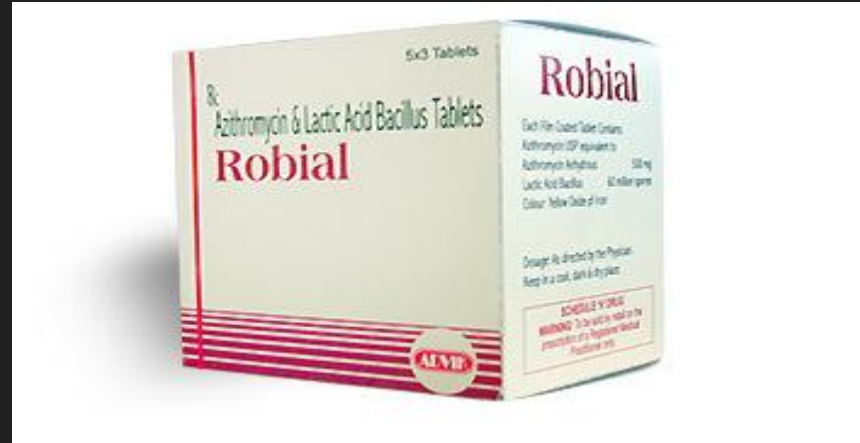




# PRODUCT DETAILS(Generic) :



- This medication is prescribed for treating certain bacterial infections, and preventing anthrax. It is a quinolone antibiotic. It kills sensitive bacteria.



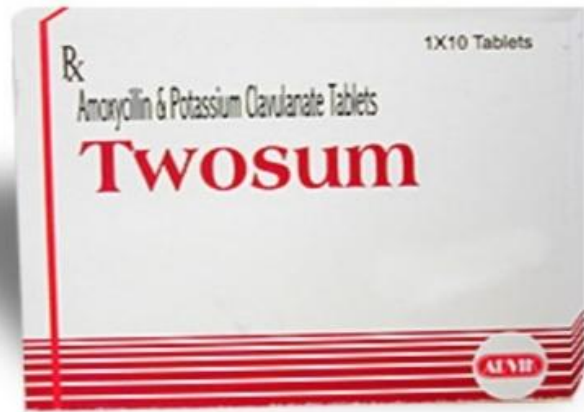
- This medication is a macrolide antibiotic used for various bacterial infections such as infections of the middle ear, throat, bronchus, sinuses, skin and soft tissue. It is also useful in treating pneumonia, typhoid, gonorrhoea, granuloma inguinale and chancroid. It prevents bacterial growth.



- Chewfe C Tablet is used for Iron deficiencies, Anemia, Treatment of megaloblastic anemias due to a deficiency of folic acid, Treatment of anemias of nutritional origin, Pregnancy, Infancy, Or childhood, Scurvy, Cell damage, Wound healing, Tissue repair, Red blood cell production and other conditions



- Below are some of the details of Calcium Citrate + Vitamin D3(generic)
- This combination medication is used to prevent or treat low blood calcium levels in people who do not get enough calcium from their diets.



- Twosum Tablet is a penicillin-type of antibiotic that helps your body fight infections caused by bacteria. It is used to treat infections of the lungs, ear, nasal sinus, urinary tract, skin and soft tissue. It will not work for viral infections such as the common cold.



- This medication is a non-steroidal anti-inflammatory drug (NSAID), prescribed for dysmenorrhea and other pain. It decreases inflammation and uterine contractions.



- Aluminum hydroxide is used for the relief of heartburn, sour stomach, and peptic ulcer pain and to promote the healing of peptic ulcers.
