# 6. Framing of question paper pattern for SEE of B.Voc. (Chem. Tech.) and B.Voc. (Pharm. Analysis & QA) programmes.

During the discussion for the above mentioned agenda, Dr. Kalpesh Menpara (Member-Alumnus) suggested to frame the question paper pattern that can accommodate more number of questions, and avoiding very long answer questions. He added, "This would be more relevant as B.Voc. programmes aim to develop practical skills of students, and not the writing skills." Dr. Y. J. Fernandes (AC Nominee) added that having more number of questions will also provide more options to both, students and paper setters. After the discussion, the members **framed** the question paper pattern for SEE of B.Voc. (Chem. Tech.) and B.Voc. (Pharm. Analysis & QA) programmes for students admitted from A.Y. 2017-18 & onwards.
