BAAG and MNVSC agree:

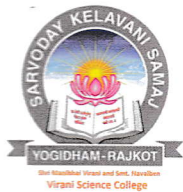
- to exchange information on applied research of mutual interests
- to exchange informative material and other literature relevant to their institutional interests
- to jointly organize short-term continuing education programs on topic of mutual interest and to invite each other's stakeholders to participate therein
- to jointly organize seminars, conferences, or workshops on topics of mutual interest and to invite each other's stakeholders to participate therein
- to jointly propose and engage in research or training programs sponsored by funding agencies, and to invite each other's stakeholders to participate therein
- to exchange, on a reciprocal basis, working members of both institutions for limited periods of time for purpose of education and/or consultancy.

BAAG and MNVSC further agree that detailed terms and conditions that guide each activity identified above will be separately determined and agreed upon by the two institutions. These terms shall include a technical description of the proposed activity, financial arrangements, and person(s) responsible for its implementation, etc.

Intellectual Property:

BAAG and MNVSC agree to respect each other's rights to intellectual property. Further, the intellectual property rights that arise as a result of any collaborative research or activity under this MoU will be worked out on a case-by-case basis, and will be consistent with the officially laid down IPR policies of the two institutions.

Finance:

Financing of the activities to be carried out under the agreements will be sought and arrangement will be on an individual case basis.

The travel expenses related to the activities will be responsibility of the visiting party. However host agency will make every possible effort to assist the visiting party.

Validity:

This MoU becomes effective on the date of signature. It is valid for THREE (3) years with the understanding that either institution may terminate the MoU with three (3) months' notice in writing, unless an earlier termination is mutually agreed upon. Revisions or modifications may be proposed at any time, effective from the date of written agreement signed by both institutions.

FORCE MAJEURE:

Neither party shall be liable for non-performance either in whole in part of this agreement due to reasons unforeseen and beyond its control. These reasons shall include and be strikes, lockouts, nationalization, acts of God, war and fire. In that event, the other party will be immediately in writing detailing full facts of the case and both parties will undertake to arrive at mutually satisfactory solutions to overcome the difficulties arising out of these circumstances.

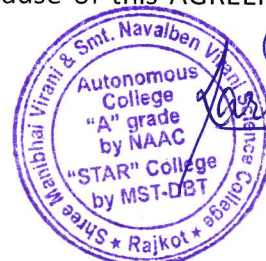
ARBITRATION:

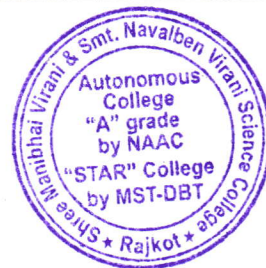

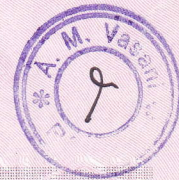
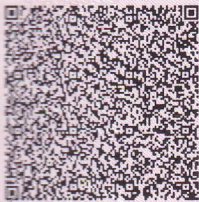
